Ministerial Decision

The Minister of Human Resources and Social Development, Based on authorities duly granted to him.

Having reviewed the provisions of Articles (3, 11 bis, 27, 36) of the Labor Law issued by Royal Decree No. (M/ 51) dated 23/08/1426 H, amended by Royal Decree No. (M/24) dated 12/5/1434 H, amended by Royal Decree No. (M/ 46) dated 05/06/1436 H, amended by Royal Decree No. (M/14) dated 22/02/1440 H, and amended by Royal Decree No. M/ 134 dated 27/11/1440 H.

Based on the Memorandum of Understanding concluded between the Emirate of Ha'il, and the Ministry of Human Resourcse and Social Development on 12/05/1439 H, and the recommendations of the Supreme Committee for the localization and Social Development Program in Ha'il Region headed by His Royal Highness the Prince of Ha'il Region on 17/02/1441 H, on the localization of some activities and occupations in the region.

Based on the public interest.

decides as follows:

First: Work is restricted to Saudis of both genders in occupations and activities according to the following details:

Second: Names of the activities mentioned in clause (1) shall be according to what are mentioned in the ISIC4 classification according to the details mentioned in the attached schedule.

third: Adhered to feminization decisions and women's working conditions when employed in relation to the activities and shops for which decisions have been issued.

Fourth: This decision to localization activities is valid for Saudis according to the percentages and exceptions mentioned in clause (1) after 90 days from the date of this ministerial decision.

Fifth: The statutory punishment for the violation applies to employing non-Saudi workers in occupations that are restricted to Saudis set forth in the violation and penalty table issued by ministerial decision No. 178743 dated 27/09/1440 H, taking into account any amendments that occur in the future. Sixth: This decision is implemented in accordance with the ministerial decisions issued for localization. In the event of different localization rates, the higher percentage will be applied.

Seventh: the vice Minister of Labor sector takes the necessary measures to inform and implement it.
